

Enhancing Fire & EMS Response in Northern Albemarle County

A responsive, professional fire rescue system is vital to our community's well-being. In response to a gap in existing service and an increase in demand for services in the Route 29 North corridor (Hollymead area), a new fire rescue station is under construction. The new fire rescue station will be located off Airport Road on property adjacent to the University of Virginia Research Park. The station will serve an area of approximately 94 square miles.

Completion of the permanent facility is scheduled for Fall 2007

Temporarily, emergency services are being provided from a facility at the Charlottesville-Albemarle Airport until station construction is complete. The new station will house an ambulance, engine, ladder, and water tanker. When the station opens in 2007, the Hollymead community will benefit from enhanced fire and emergency medical resources. The station will be staffed 24 hours per day, seven days per week with both career and volunteer staff.

Volunteer Opportunities

Senior Volunteer

Pull one twelve-hour duty shift per calendar week • Pull one twenty-four hour duty shift every sixth weekend.

Associate Volunteer

Individuals whom are affiliated with another volunteer fire, rescue, and/or EMS organization or individuals who desire to volunteer solely as a vehicle operator are eligible for associate volunteer status; 12-hour duty shift every other week; one 24-hour duty shift every sixth weekend.

Support Volunteer Opportunities

Persons who have the desire to volunteer but would like to serve in a non-operational role such as data entry, buildings and grounds, etc., are eligible for support volunteer status; 8-hours of service per month.



Live-In Program

Four individuals are competitively selected to participate in the live-in program • In exchange for volunteer service as a live-in, the individual is entitled to all benefits enjoyed by other Albemarle County Fire Rescue volunteers plus: • Room (furnished) • Board (limited) • Computer Access • High-Speed Internet • Cable • Telephone (must provide own long distance service) • Living Quarters with Separate Shower/Bath • Uniforms/Personal Protective Equipment • Fitness Facilities • On-Site Mailbox

To apply for the live-in program, an individual must be:

- Eighteen years of age (minimum)
- A released firefighter and released EMT-Basic at time of application or by conclusion of six-month probationary period
- Employed or full-time student, in good standing—or combination thereof

Live-in Volunteers must meet these duty requirements:

Three 12-hour duty shifts per calendar week • One 48-hour duty weekend every sixth weekend • The live-in volunteer is entitled to four weeks of leave each calendar year. • Live-in program volunteers must also meet other expectations and requirements. Please contact us for more information
